1. 26 June 37 Eliz. [1595]

Gilbert Withers of Dummer, Hants., yeo., son of George Withers v William Dumer, sometimes of London, esq., Humphrey Bridges of Lincoln's Inn esq., his steward, purchaser of the manor and John Millingate of Dumer, yeo. Validity of a lease made in 8 Eliz. of the manor of West Dummer alias Westercourte, psh Dummer, made by William Dumer to William Withers for 45 years in reversion but fraudulently dated after the conveyance of the manor to Bridges.

2. 7 July 37 Eliz. [1595]

Thomas Gerrard esq., son and heir apparent of Sir Thomas Gerrard, Walter Gifford, Francis Cooke esq., and William Fowler v Edward Kynnersley, gent. Relief from actions on bonds by which the plt bound to the dft.

3. 19 June 36 Eliz. [1594]

Roger Lord North, lord of the manor of Hayes, Midd. v Richard Millett, son of John Millett of Hayes, Midd., yeo.

Validity of a lease in reversion of the manor and demesnes of Hayes made by the plt's father to dft's father.

4. 29 Jan. 35 Eliz. [1593]

Richard Bacon of West Grinstead, Sussex, husbn, son of Thomas Baon decd v Thomas Shirley esq., lord of the manor of West Grinstead, and Richard Shirley gent.

Alleged forfeiture of a copyhold and « yardland called Tucknames by plt's father; profits of the tenement during the plt's minority.

5. 11 Nov. 38 Eliz. [1596]

Edward earl of Worcester, owner of the lordship of Gower v Sir William Herbert, Hopkyn David, George Francklin, John ap Evan, Robert Smythe and 12 others named, and all the tenants of the lordship of Gower and Kilbey. Custom of mises due to the plt on entry into the lordship.

6. 13 Feb. 40 Eliz. [1598]

John Horseley, son of Edmund Horseley decd, by his second wife Thomasine, decd v Joan Horseley, widow of Thomas Horseley decd and Roger Hayes and Elizabeth his wife, first wife of Edmund Horseley decd and mother of Thomas.

Possession of two messuages and lands in Huntington and Levington, Staffs., late of Edmund Horseley; claim that the premises conveyed to plt by his parents during their lives.

7. 28 April 39 Eliz. [1597]

Richard Symons, a chancery cursitor v Thomas Jobber and John Symons, brother of plt.

Messuage called Cockenhall in Idsall, Salop., settled by one Francis Milward decd on plt's father subject to the payment of rent charge to the poor people of the parish.

8. 3 May 39 Eliz. [1597]

Michael Penyston of London, draper, Thomas Hauslopp of Solihull, Warw., gent. v Roger Vaughan of Clero, Radnor, esq., Roger Vaughan of Newchurch, gent. and Eleanor Vaughan his daughter, infant.

Possession of a tenement and 200 ac in Glasnett/Glasnant, psh Brougwyne, Radnor, and two tenements and 400ac in Michellchurch, Radnor, conveyed to plt by John Powell of Kineton, Heref., gent.

9. 5 Feb. 39 Eliz. [1597]

John Chippingdale, Doctor of Law v Edward Wigley, George Wigley, sons of Henry Wigley and Elizabeth his wife, both decd and Henry Wigley, son of George.

Possession of a leasehold interest in a messuage, cottages and 5« yardlands parcel of the manor of Scraptoft, Leic., and leased to Henry Wigley by conventual lease of Coventry Abbey.

10. 16 Feb. 40 Eliz. [1598]

Sir Francis Carewe, lord of the manor of Beddington, Surrey v Richard Bonnyck of Horley, Surrey, yeo.

Detention of rents and services of freehold lands called Lake Lands in Horley held of the manor of Bedington.

11. 1 Feb. 40 Eliz [1598]

Thomas Beare clerk, vicar of Swarnebey [?Swarby], Lincs. v Richard Fayerfax, lay improprietor, and Richard Okes.

Plt's entitlement to small tithes and pensions payable to the vicar of the parish.

12. 8 Feb. 40 Eliz. [1598]

Philip Gwilliam of London, fishmonger v Ralph Hopkins and Edmund Harvy. Redemption of the plt's mortgage to Hopkins of a capital messuage in Llangeston, psh Llangarran, Heref., a water corn mill and other lands there to the dft; actions on bonds for money borrowed from Harvy.

13. 30 April 39 Eliz. [1592]

Nicholas Gaywood of Bishops Offley, Staffs., gent. v Philip Bunghey and Thomas Homersley.

Rents issuing from a messuage in Sugnall, Staffs.

14. 30 Jan. 40 Eliz. [1598]

Nicholas Pill, merchant v Richard Wysman.

Breach of agreement to trade together: embezzlement of plt's portion of oil and raisins shipped from Spain,

15. 16 June 40 Eliz. [1598]

Dorothy, Lady Pelham, widow of Sir William Pelham and previously of Sir William Dormer decd., son and heir of Robert Dormer esq. v Sir John Seymour, lord of the manor of West Wycombe, Bucks., and Robert Odbeare. Attempts to secure the forfeiture of the plt's lease of the manor of West Wycombe; dft's right to hold courts and fell timber.

16. 4 July 40 Eliz. [1598]

Sir Thomas Waller of Brenchley, Kent v Sampson Leonard esq. and Lady Margaret Dacre his wife.

Attempts to secure the forfeiture of plt's lease of marsh grounds called Oulde Courte, The Hundred Acres, The Oulde Courte Mote and the Oulde Court Crofte in psh Wartling and Herstmonceux, Sussex.

17. 10 Feb. 41 Eliz. [1599]

Edward, earl of Oxford v Roger Harlackden, his surveyor and receiver and Richard Harlackden his son.

Frauds in the purchase of Earl's Colne, Essex, from the plt; question of whether other manors and tithes late of Colne Priory were conveyed to the dft by virtue of general words.

18. 2 Dec. 41 Eliz. [1598]

Roger Gyttyns gent., son and heir of Emma Gyttyns decd v Anthony Browne esq., and Elizabeth his wife.

Refusal to admit plt to his mother's copyhold lands held of the dfts' manors of South Weald and Calcott, Essex; custom of fining of the manors.

19A. 10 Feb. 41 Eliz. [1599]

Sir Thomas Walsingham, Edmund Cooke esq., William Barne esq., William Smith and 25 others for the inhabitants of the hundreds of Blackheath Little, Lessness and Ruxley, Kent v Oliver Leigh esq., lord of the manor of East Wickham, Kent.

Agreement concerning a common way through the manor which the parties agreed was dangerous for safe passage; agreement to establish a new way and assign the old to the dft to enclose.

19B. 19 Oct. 40 Eliz. [1598]

Mathew Carew, Doctor of Law and a master in Chancery and Christopher Hampden esq. and Elizabeth his wife, widow and executrix of Humphrey Donat/Donnet decd v William Barlow clerk, parson of Orpington, Kent. Lease of the rectory of Orpington, Kent.

20. 19 Feb. 33 Eliz [1591]

Edward Tyrrell of Ashdon, Essex, esq. and Elizabeth his wife v Pexall Brockas and Francis Heidon/Heydon esqs.

Plt's conveyance of manors in Essex and Cambs. to dft for the settlement of debts and in trust for plt and their heirs; peculation of sums paid to Brockas.

21. 19 Nov. 42 Eliz. [1599]

William Willson of Monk Fryston, Yorks., esq. v William Hamond, plt's brother in law and Richard Nicholson.

Terms of a conveyance by the dft of freehold and copyhold lands in Sherburn, Milford and Laverton, Yorks., to plt.

22. 13 Nov. 41 Eliz. [1599]

John Tregonwell of Milton [Abbas], Dorset, esq. v John Reves esq. Possession of the farm of Luccombe, question of whether it a parcel of the manor of Milton.
