

1. 19 June 33 Eliz. [1591]

Thomas Alcocke gent., Ralph Essex, Richard Ames, Richard Rule and four others, for themselves and the other inhabitants of Rampton, Camb. v Sir Francis Hynde, lord of the manor of Crowland and Lyles in Cottenham, Camb., George Peppes, Robert Banckes and Thomas Jackson. Right of the plt to common of pasture in a close called Oxam alias Great North Fenne in Cottenham, Camb.

2. 31 Oct. 32 Eliz. [1590]

Mathew Freer, son and heir of William Freer, late of Aylesbury, Bucks., lab., decd, who was the son of Richard Freer decd v Richard Freer late of Aylesbury, mercer, son of Richard Freer, plt's grandfather. Descent of copyhold lands called Brookes landes held of the manor of Bassetsbury, psh High Wycombe, Bucks.

3. 27 May 32 Eliz. [1590]

Francis Clapham of Peterborough, Northants., gent., youngest son of Christopher Clapham esq. of Beamsley, Yorks., decd v Francis Redman gent., whose father, John Redman esq., purchased the manor of Over Lund in Thornton in Lonsdale, Yorks., from William Clapham, plt's brother. Recovery of arrears of an annuity of £4 issuing from the manor of Over Lund granted to the plt by his father.

4. 30 June 32 Eliz [1590]

John, Thomas and Barbara Catchmede, Cornelius Avenante and Elizabeth his wife, and George Avanante, for themselves and other poor kinsfolk of Anne Kitchine decd, widow of John Kitchine esq. v the said John Kitchine of Gray's Inn, Midd., esq., and Arthur Hewet of psh All Hallows, London, draper, an executor of Anne Kitchine. Execution of the will of Anne Kitchine (1581) and legacies left by her to the plt: recognisance made by John Kitchen before his marriage to Anne Kitchin whereby he undertook to allow her to bequeath jewels and £500.

5. 21 Nov. 35 Eliz. [1592]

John Lyte of North Curry, Som., gent. v the Dean and Chapter of Wells, Som., lords of the manor of North Curry. Refusal to admit the plt to copyhold lands.

6. 23 Oct. 33 Eliz. [1591]

Robert Woodward of Watford, Herts., yeo., son and heir of William Woodward yngr v Henry Martyn and Joan his wife and Thomas Ewer. Possession of a messuage and 10 acres in Garston, psh Watford, claimed by the plt to be his freehold by inheritance and by the dft to be Ewer's copyhold held of the manor of Cashes.

7. 13 June 34 Eliz. [1592]

John East of Sutton, Lincs., clerk and Mary his wife, a dau and heir of John Ramridge of Stopsley, Beds., yeo., decd, John Rogers, son and heir of Katherine Rogers, another dau., Agnes Deremoure and Elizabeth Deremoure, daus and heirs of Agnes Deremoure, decd, another dau. v Richard Peter of

Luton, Beds., overseer of the will of John Ramridge and Robert Burr of Little Brickle [Brickhill], Bucks., yeo.
Administration of the estate of John Ramridge decd, house and 60 acres in Stopsley, Beds; failure of Peter to arrange the sale of the messuage and to distribute the consideration amongst the plt as laid down in the will of John Ramridge.

8. 12 June 34 Eliz. [1592]

Thomas Prettye of Wartling, Sussex, yeo. and Lucy his wife, dau. and heir of William Tookye decd v Anthony Hatheropp of Brenchley, Kent, yeo.
Possession of 200 acres of land in Heathfield, Sussex, called Mylkeherst, late John Tookye of Wartling, decd, plt's grandfather.

9. 10 Feb. 34 Eliz. [1592]

William Baxter, yeo. and Richard Garner yeo., both of Dogstrophe, Northants., for themselves and the inhabitants of Dogstrophe v Thomas Lovedaye, John Pancke, Anthony Hatherston and others, tenants of the manor of Peterborough.

Common of pasture claimed by the dft in open arable fields within the manor of Burghbury called Woodfield and Sallowes.

10. 3 May 34 Eliz. [1592]

Thomas Arwyn of Herringswell, Suff., clerk and John Owers elder of Wickhambrook, Suff., husbn v Charles Parman of Wickhambrook.
Possession of grounds in Wickhambrook which the dft sold to the plt: discovery of the truth of the dft's claim that he had no title in the lands because of an entail in favour of his son.

11. 10 Oct. 31 Eliz. [1589]

Francis Tempest of Doncaster, Yorks., gent., and Bridget his wife, widow of Nicholas Haulgh decd v Thomas Ellis, Nicholas Yates and Robert Browne, the last two being executors of William Haulgh, plt's son, decd.
Possession of a lease of the parsonage of Wigtoft, Lincs.

12. 25 Nov. 34 Eliz. [1591]

Sir William Fitzwilliams, Lord Deputy of Ireland and William Fitzwilliams of Dogstrophe, Northants., esq., his son and heir apparent v Sir John Harrington, Robert Forth DCL, Nicholas Bonde DD, Henry Bosville esq., all executors of Frances, countess of Sussex, decd and Henry Beacher, citizen and haberdasher of London.
Petition that the dfts might acknowledge the discharge of a statute staple of £800 made by the plt to Beacher for payment of £533 6s 8d and assigned by him to the countess.

13. 26 June 33 Eliz. [1591]

John Osbaston of Nottingham, merchant of the staple v John Haslopp of Cambridge.
Actions on bonds made between the parties for the delivery of 60 qrs of malt to Osbaston.

14. 17 June 33 Eliz. [1591]

William Nicholls gent. v William Beacher and William Mynne, both of London.
Action on a bond of £500 made between the plt and others and Beacher for

the payment to the dfts of £250 on the delivery of 80 `papers of Firrett silke'.

15. 20 Oct. 31 Eliz. [1589]

John Brown of Frampton, Dors., esq., son of John Brown decd v Robert Freake esq.

Breach of trust: an assignment made by the plt's father of his lease of the rectory of Frampton, Dorset to the dft on trust that he would surrender the lease and take a new one to the use of the plt's father and his children.

16. 20 Oct. 32 Eliz. [1590]

John Middleton of London, son and heir of Richard Middleton of Harden, Flint., decd v John Hanmer, Jane his wife, George Salisbury of Easbistock, Flint, gent.

Possession of a capital messuage and lands in the town of Hevllan Lliveny, Denb. which dfts John and Jane Hanmer conveyed to the plt's father; frauds in the conveyance.
