Amy Pyncombe, dau. of Richard Doddridge of Barnstaple, Devon, merchant and widow and administratrix of John Pyncombe the younger of South Molton, merchant, decd and John Pyncombe their eldest son and heir v John Bond and Roger Prowse both of Taunton, Som., gents, Stephen Domynicke of South Molton mercer, William Toocker, John Webber and five others, all executors of John Pyncombe, elder of South Molton, decd.

Revivor of disputes concerning the settlement of the estate of John Pyncombe elder in South Molton on the marriage of John Pyncombe to the plt: action on a bond of £400 commenced by the dfts against Amy Pyncombe as executrix.

2. 6 June 6 James I [1608]

John Dunch, bachelor of Divinity, William Piggott, Jonas Dunch, Robert Lyle, Luke Dunch and seven others, for themselves and other copyholders of Stuntney in the Isle of Ely v Sir Simeon Steward, lord of the manor.

Ratification of an indenture between the parties of 30 April 6 James I [1608] for the division and enclosure of the fens, moors and commons of the manor.

Mary Coombes, then widow and executrix of Edward Coombes esq. and now wife of Richard Shute esq. v John Stone of the Inner Temple esq. and Philip Stone his brother.

and Anthony Fawkener, gent., his steward.
Attempts by the dfts to amend the customs of the manor: plts' claim of a custom of
fixed fines and a right to common in two fields called Cowe Pasture and Nether Cowe
Pasture.

John Elvered alias Skynner, John Lovett, Thomas Wilkins and John Morley of
Shropham, Norf., in their names and on behalf of the other inhabitants of Shropham

Right of the dft to common of pasture in the commons belonging to the inhabitants

Great Beckles, [Great] Hockham and Stow [Bedon], Norf.
8. 20 Nov. 4 James I [1606]
Anthony Edmondes of Ropley, Hants., gent., younger son of John Edmonds of
Bayles Courte, psh Little Hampton, Sussex, gent. v Walter Edmunds of Bayles Court,
gent., eldest bro. of the plt.
Conveyance of the estate of John Edwards in Chiddingfold, Surrey: question of
whether dft should have conveyed it to the plt in fee simple or fee tail in accordance
with the will of their father.
9. 13 May 3 James I [1605]
Sir Arthur Chichester and Dame Lettice his wife, widow of Walter Vaughan of
Golden Grove, Carms., esq., decd., on behalf of themselves and as guardians to Jane

Vaughan and Elizabeth Vaughan, infants, her daughters v Sir John Vaughan, son and heir of Walter Vaughan by his wife Mary, and others.

Possession of 80 messuages in Carmarthenshire conveyed by Walter Vaughan to trustees as dower for Dame Lettice, with remainder to the heirs born to him of Dame Lettice.

10. 11 Oct. 3 James I [1605]

John Herring of Mendham, Suff., yeo., a son and executor of Thomas Herring late of Wingfield, Suff., decd v Bartholomew Styles.

Lease of a messuage in Wingfield, Suff. made to the dft on trust to try the title.

11. 9 June 2 James I [1604]

Thomas Fracye of Langham, Rut., lab. v Sir Andrew Noell, lord of the manor of Langham.

Refusal to admit the plt to a copyhold tenement and two yardlands in Langham: enclosure of the lands by the dft and loss of the plt's common.

12. 22 May 2 James I [1604]

Elizabeth Grudgfild, Richard Porter, Robert Foxe and others, customary tenants of the manor of South Elmham, Suff. v Dorothy, Lady North and Dudley, Lord North, lord of the manor of South Elmham, William Forthe and Arthur Forthe, gents.

Composition between the parties to establish a custom of fixed fines and rights to fell timber.

13. 2 May 2 James I [1604]

Ellys Brame, Richard Shawe, Thomas Shawe, Henry Dowsing, James Watson and nine others, copyholders of the manor of Hoohall in Oakley, Suff. v Sir Thomas Cornwallis, lord of the manor and Sir William Cornwallis his son.

Ratification of copyhold grants to plt made by Sir Thomas Cornwallis of parcels of Oakley Common.

14. 16 Oct. 42 Eliz. [1600]

Richard Howe gent. and John Cocke, churchwardens of Stowmarket, Suff., for themselves and the inhabitants of Stowmarket v John Howe, son and heir of Robert Howe and grandson of John Howe of Stowmarket, clothier, decd and others.

Possession of lands in Stowmarket bequeathed by James Revett late of Rattlesden, Suff., esq. to the use of the poor and detained by Thomas Revett his son: bequest to the parish of Stowmarket by John Howe of an annuity of £4 to be paid from a pasture or wood called Chilton Heywood in Chilton, psh Stowmarket and from copyhold lands of the manor of Combes Hall in Combes, Suff. to the use of the poor.

[The decree bears only on the annuity bequeathed by John Howe.]

15. 13 April 41 Eliz [1599]

John Dryland of London, gent. v Henry James esq., son and executor of Martin James esq., decd.

Action on the covenants for possession in a conveyance made by the plt to Martin James of marsh grounds called Upper Howlettes, Nether Howlettes and Lodge Marshe in Luddenham, Oare and Faversham, Kent: refusal of the dft to accept sums in compensation contrary to agreement.

16. 4 Nov. 39 Eliz. [1597]

David Lloyd James, Hugh Lewys, Peter Powell and Maurice Morgan of Dessertt, Radnor v Richard Dawes.

Relief from an action on a bond brought by the dft against David Lloyd James and the other plts, his suerties, after the bond discharged by a new settlement with the dft.
