Debts due from manor of West Burton, North Wheatley, South Wheatley, Bourle and Sawneby, Notts.
3. 19 June 16 Chas. I  
Henry Barnardstone v William Gery and another (named).  
Assignment of lands in pursuance of a trust in Norill, Beds.
4. 20 June 16 Chas. I  
William Holmes v Thomas Holmes the elder and another (named).  
Marriage settlement of lands in Atemson and Twyford (county not given).

Bill (Trinity last) seeking court ratification of agreement (Nov. 5 Chas.) between Lord and incumbent to enclose the manor and allocate new glebe lands. Shanckton, Leicestershire.

Mortgage of lands and kiln at Bitswell, Leics.

Leases of lands in Ashton and Pury, Northants, used as security for bond.
