John Nott, son and heir of John Nott late of Abberley, Worcs., decd v William Welshe, lord of the manor of Abberley, Richard Nott, plt's uncle, Edmund Nott and William Child, steward of the manor.

Inheritance of a copyhold of two messuages and 1« yardlands called Croundallend in Abberley.

2. 14 Nov. 36 Eliz. [1594]

Peter Roos of Laxton, Notts., esq. v William Foster esq., William Hall, Thomas Wayte, Thomas Browne and Thomas Barloe.

Possession of the manor of Maxstoke and Metlin [Metteley] and Maxstoke Hall in Maxstoke together with other lands in Warw.

3. 16 Oct. 37 Eliz. [1595]

John Thynne of Longleat, Wilts., esq. v Edmund Leversage of Vallis [in Frome], Som., esq.

Failure to complete the conveyance of 12 parcels of waste grounds in Frome Selwood, Som., purchased by the plt from the dft.

4. 24 Nov. 37 Eliz. [1595]

James Brett of Hoby, Leics., gent. v Sir George Villers.

Suit to bring about the enrolment of a reciprocal lease for 41 years dated 1 April 35 Eliz. of a messuage and 3 yardlands and meadow in Hoby, Leics.

5. 15 Nov. 37 Eliz. [1594]

Eleanor Maddock, dau. of John Maddock v David Edowe, Richard Edowe his son, John Edowe and John Dodd.

Inheritance of a watermill, closes called Withwood, New Leysowe, Henvas and the Myll Field in Iscoyd, Flint, formerly of Thomas Colly of Iscoyd.

6. 26 Nov. 38 Eliz. [1595]

Agnes Warde, widow of Richard Warde, citizen and Innkeeper of London, decd, Thomas Warde her son and administrator of Warde's estate v Martin Cowper clerk, warden of the college of twelve pensioners of St Paul's and the canons there, Thomas Riche and Maurice Mabell.

Double leasing of a tenement called Connyehowse in psh St Faith, London; claim that the plt's lease void.

7. 20 Nov. 39 Eliz. [1596]

Richard Wilkinson of Frindsbury, Kent, gent. v John, bishop of Rochester, Thomas Wardegar, John Younge gent. and John Herne.

Lease of the parsonage of Frindsbury and Strood, Kent, made by the bishop of Rochester to the other dfts after the plt's lease declared to be forfeited.

8. 26 Jan. 39 Eliz. [1597]

Richard Willoughby of Nuneaton, Warw., tanner v Richard Powle, John Olyver, Roger Bowman (a suerty of Powle's) and others.

Sums of money owed to the plt by the dft; state of accounts between them.

Mayor and Citizens of Chester v Robert Brooke, citizen and alderman of London and Robert Offeley jun., executors of the will of Robert Offeley sen., late citizen and haberdasher of London.

£600 bequeathed by Robert Brooke to for a common fund to be lent to the younger freemen of Chester.

10A. 11 Feb. 39 Eliz. [1597]

Joan Bladon v Henry Trickett clerk and Henry Trickett jun.

Life estate in a messuage in Branston, psh Burton upon Trent, Staffs. and lands.

10B. 27 Jan. 39 Eliz. [1597]

Richard Lechford of Leigh, Surrey, esq. v Edmond Saunders esq., son of Thomas Saunders.

Lease of lands called Cowpers and Lydlandes in Charlwood, Surrey and the rectory of Leigh, Surrey, allegedly made to Thomas Saunders by Sir Robert Southwell.

11. 14 Nov. 36 Eliz. [1596]

Thomas Turgis, William Sterte, John Heath, Nicholas Alderton, John Stynte and 44 others on behalf of themselves and the other copyholders of the manor of Petworth, Sussex v Henry, earl of Northumberland.

Customs of the manor of Petworth, compensation for common rights in parts of the common or outwood of Petworth now enclosed within dft's parks.

12. 28 Oct. 39 Eliz. [1597]

George Russell v William Symons and Thomas Brabon.

Action on a statute of £400 acknowledged to the plt by Henry Knyghte of Chalton, Hants, decd.

13. 9 May 39 Eliz. [1597]

George Jackson of Gatenby, Yorks., gent., son of John Jackson decd v Anthony Kempe and William Waller esqs.

Action on a recognisance by which John Jackson and Ascoulphe Cleasbye of Moulton, Yorks, gent., became bound to Anthony Kempe in £20,000.

Elizabeth Lady St John of Bletso [Beds.], wid., sometime wife of Sir Walter Stoner, decd, then of Reignold Conyers esq., decd, and after of Edward Griffyn, of Dingley, Northants., esq., sometime attorney-general to Edward VI and Queen Mary, decd v Edward Griffyn, son of Edward Griffyn, Walter Hastings, Thomas Bawde and Andrew Grey esqs.

Arrears of rent of the plt's jointure granted by Edward Griffyn in the manors of Stoke Albany, Wilbarston, Horingholde, Great Oxenden, West Chelworth with apps in Northants., Leic., and Som., various advowsons, Stoke Park in Stoke Albany and other property.

Estate of Thomas Aspinall including a messuage in Golding Lane, psh St Giles Cripplegate called 'The Three Arrows', disinheritance of Katherine Aspinall alias Brytten.

5. 21 May 38 Eliz. [1596]

Richard Weller of Mayfield, Sussex, yeo., husband of Margaret, widow and executrix of John Weston v Thomas Holney, Thomas Baker, Abraham Langham, Richard Tichborne, Thomas Ainscombe and others.

Validity of a lease for 60 years or life of the manors of Farley and Whipperley [Stockweard in Luton psh], Beds., made by George Rotheram to Sheldon and Isaac Rotheram in trust for Anne Rotheram.

8. 17 Nov. 40 Eliz. [1597]

Francis Sherrard of Stapleford, Leics., esq., son and heir of George Sherrard esq., decd v Roger Smyth and William Cave esqs, trustees for George Sherrard.

Elizabeth Hobson, widow and administrator of Charles Hobson, citizen and tallow chandler of London, decd v John Hampton, Roger Richardson and Cicely Newman, widow and executrix of John Newman, citizen and haberdasher of London, decd, and father in law of Charles Hobson.

Assignment of two houses in St Botolph without Bishopgate to Newman in satisfaction of bonds, who, notwithstanding, had their execution and seized Hobson's goods and furnishings.

John Colley of Betley, Staffs., yeo. v Ellen his wife, widow of Robert Lownes of Betley decd v John Yonge of Charnes, Staffs., gent. and Ellen Lownes wid., mother of Robert.

Possession of a lease of a tenement in Betley.

Nicholas Slannyng of Ley in psh Plympton St Mary, Devon, esq., nephew of Nicholas Slannyng of Bickleigh, Devon, esq., decd v Edward Marler of London and Agnes his wife, daughter of Nicholas Slannyng.

Settlement by Nicholas Slannyng of his estates in Bickleigh and elsewhere on his heirs males, payment of monies to the dfts under the terms of the settlement.

5. 16 Nov. 33 Eliz. [1591]

John Shymeng and Margery his wife v Sir Arthur Hevenyngham, lord of the manor of Heveningham, Suff. and Esayas Yarner.

Eviction from a copyhold of the manor of Heveningham leased by Hevenyngham to Yarner.

John Browne of Enfield [...], Helen his wife, Thomas Dippen, Joan his wife and Barbara Francis, wid, cousins and coheirs of Edward Marshall, decd, and daughters of Robert Marshall his brother v Jonas Taylor.

Recovery of two copyholds held of the manor of Cheshunt, Herts., surrendered to dft by Edward Marshall for three years for the settlement of gambling debts.

Refusal of Chapman to accept the repayment of the consideration of a conveyance of a third part of tenements in pshs St Mildred Bread Street and St Botolph without Aldersgate, London, late the estate of Richard Wayman.

13. 15 Nov. 35 Eliz [1593]

Edward Cary esq. and William Dodington, gent., executors of the will of Sir Walter Mildmay decd v Anthony Mildmay esq., son and heir to Sir Walter.
Administration of the estate of Sir Walter Mildmay, lease by Sir Walter to the plts of the manor of Great Leesthorpe [in Pickwell psh], Leics. in trust for the settlement of his debts and legacies.

4. 13 April 28 Eliz. [1586]

Francis Capelyn of Clifford's Inn, gent., younger son of John Capelyn v John Capelyn elder, son and executor of John Capelyn of Southampton, gent., Robert Creswell and Nicholas Capelyn, overseers to whom first dft bound for the performance of John Capelyn's will.

Performance of the will of John Capelyn elder.

5. 12 May 29 Eliz. [1587]

John Chocke of Shalbourne, Wilts., gent., and Francis Chocke his son v Richard Chocke, servant of Francis Chocke decd, eldest brother of John Chocke, and Alexander Chocke, son of Richard.

Possession of the property of the late Francis Chocke, brother of plt, including the manors of Avington, Radley and Denford, Bucks., an inn called the 'Sign of the Bell' in Hungerford, Berks., and the manors of Standerwick and Luckington in Kilmersdon], Som., entailed in fee male. Alleged disinheritance of plt.

William Redman clerk, archdeacon of Canterbury and son of John Redman and Margaret his wife v (i) Christopher Torrell, now decd; (ii) a bill of revivor against Frances Torrell his widow and executrix; (iii) Henry Josselyn, esq.,

Lease in reversion of the site of the manor and demesne lands of Great Shelford, Camb., made by Thomas late Bishop of Ely to the plt's parents.

7. 16 Nov. 29 Eliz. [1587]

Action by the dft on a statute of £2,000 made in 28 Henry VIII; securing an extent of the manors of Siston and Fairford, Glos, seizure of goods of Dennys.

8. 17 Nov. 29 Eliz. [1586]

Thomas Gawen esq. and Joan his wife, widow of Edward Harward, citizen and draper of London, decd v Thomas Andrews, Sampson Machedon, vicar of St George Eastcheap, Thomas Wylford churchwarden, Robert Daborne and Robert Proctor.

Right of plt to the manor of Duvell in Bampton, Devon and other lands formerly of Thomas Crewse decd as heir male to Crewse by a settlement of 23 Henry VI.
